## Executive Summary

Currently, there are more than 1.2 million homeless youth enrolled in schools across the nation. Children experiencing homelessness are more likely to suffer academically and are more likely to drop out of school when compared to their housed peers. In Washington, the number of homeless youth has increased every year since the 2001 reauthorization of the McKinney-Vento Act, which requires all school districts to report annually the number of homeless students enrolled in schools.

In addition to the McKinney-Vento Act requirements, the Washington State Legislature passed Substitute Senate Bill 6074 during the 2014 legislative session. This bill aims to improve educational outcomes for homeless youth by bolstering homeless student identification and establishing further data reporting requirements to identify additional supports necessary for these children.

The number of homeless students represented in this table has increased over the years. In part, this increase may be accounted for by better data quality in the collection of data for homeless students.

# Introduction

## Legislation

The 2014 Washington State Legislature passed legislation (SSB 6074; [RCW 28A.300.540](#)) that requires OSPI to report homeless students data to the Legislature every other year starting January 10, 2015. This report provides a more in-depth analysis of homeless student data than is currently required by the U.S. Department of Education under the federal McKinney-Vento Act. The statewide assessment data to be reported by OSPI must include performance outcomes disaggregated by at least the following subgroups of students: White, Black, Hispanic, American Indian/Alaskan Native, Asian, Pacific Islander/Hawaiian Native, low income, transitional bilingual, migrant, special education, and gender. Additional information regarding student participation in a variety of supportive educational programs will also be included in the report to the Legislature.

## Homeless Enrollment

During the 2013–14 school year, 32,494 students were identified as homeless, which amounted to 3.1 percent of students statewide. Please visit <http://www.k12.wa.us/HomelessEd> for additional information.

## **Conclusion and Next Steps**

Washington state school districts are identifying and serving increasing numbers of homeless students every year, and the numbers continue to rise. Between the 2008-09 school year and 2013-14 school year, Washington state experienced a 56% increase in the number of enrolled homeless students reported by school districts. In many cases, school is the only stable or safe place for children and youth who are experiencing the instability of disrupted housing and high mobility.

Knowing that homelessness impacts both the academic and the social-emotional well-being of students, it is critical for school districts to have the resources and supports necessary to ensure that all vulnerable children and youth, particularly those experiencing homelessness, are identified, served and supported.
